**I acknowledge and agree that drawing and re-holstering a loaded gun is a particularly dangerous activity, and one that must be self-monitored because of the fact that I could injure myself or others during a speed draw. I therefore avow and agree that I can safely and competently draw my loaded pistol from my holster. I will not take the safety off or put my finger on the trigger during the draw until the muzzle of the gun is fully downrange and completely clear of my body. Likewise, I represent and agree that I will put the safety back on and remove my finger from the trigger before re-holstering, while the muzzle of the gun is still fully downrange and totally clear of my body.**

**I understand and agree that the representations above are an integral part of my membership application. I further understand that these representations will be relied upon by Leatham Enterprises LLC in its determining whether this application will be approved.**
